Participant shall refer to the person identified on this sheet by the signature at the bottom or the acceptance online.

CAMP shall refer to Cedar Springs Camp & Retreat.

IT IS THE INTENTION OF PARTICIPANT BY THIS AGREEMENT TO EXEMPT AND RELIEVE CAMP AND ITS OFFICERS, AGENTS, SERVANTS, OR EMPLOYEES FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE, OR WRONGFUL DEATH OF PARTICIPANT CAUSED BY ANY ACT OF NEGLIGENCE OF CAMP AND ITS OFFICERS, AGENTS, SERVANTS, OR EMPLOYEES.

For and in consideration of permitting PARTICIPANT to observe, or use any facility or equipment of CAMP, or engage in and/or receive instruction in any activity or activity incidental thereto SOME OF WHICH MAY INVOLVE DANGERS AND RISK OF BODILY INJURY at: CAMP for the duration of the event, the undersigned PARTICIPANT hereby voluntarily and absolutely releases, discharges, waives, and relinquishes any and all loss or damages or actions or causes of action for personal injury, property damage, or wrongful death occurring to PARTICIPANT as a result of PARTICIPANT's observing or using facilities or equipment of CAMP, or engaging in or receiving instructions in any activities SOME OF WHICH MAY INVOLVE DANGERS AND RISK OF BODILY INJURY or in activities incidental thereto wherever or however the same may occur, and for whatever period said activities or instructions may continue.

The undersigned PARTICIPANT for him/herself, his/her heirs, executors, administrators, or assigns agrees that in the event any claim for personal injury, property damage, or wrongful death shall be prosecuted against CAMP or its officers, agents, servants, or employees, the undersigned PARTICIPANT will indemnify and hold harmless CAMP and its officers, agents, servants, or employees from any and all claims or causes of action by PARTICIPANT or by any other person or entity, by whomever or wherever made or presented, and under no circumstances will the undersigned PARTICIPANT present any claim against PARTICIPANT and said persons for personal injuries, property damage, wrongful death, or otherwise, caused by any act of negligence by CAMP and said persons. The undersigned PARTICIPANT represent that he/she has read this Release, has requested and has been provided with, or has requested and declined advisement on the potential dangers/risks of engaging in the observation, activities, or instruction offered, assumes all risks associated with such dangers and risks, and is fully aware of and understands the terms and the legal consequences of the signing of this Release. The undersigned PARTICIPANT intends his or her signature below or his or her acceptance online, to be a complete and unconditional release of all liability to the greatest extent allowed by law and if any portion of the Release is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

PARTICIPANT further consents to any x-ray examination, anesthetic, medical, or surgical diagnosis or treatment and hospital care under the general or special supervision and upon the advice of or to be rendered by a physician and surgeon licensed under the Medical Practice Act for PARTICIPANT. This authority also extends to any x-ray examination, anesthetic, dental, or surgical diagnosis or treatment and hospital care by a dentist licensed under the Dental Practice Act for my child. PARTICIPANT further agrees to pay all charges for the dental, medical, or hospital care or treatment.
